Taught Academic Regulations

A summary of the proposed changes is detailed below and the proposed revised regulations are attached.

Addition of the following clause (specific to Apprenticeship courses):

A3.3 In the case of Apprenticeship programmes, the requirements of the end point assessment plan (EPA) associated with the apprenticeship standard will be followed and will take precedence over University regulations, subject to approval through the University's course approval and review processes.

Student Complaints Procedure

Minor amendments made for clarity, consistency and accuracy as follows:

- reference to 'you' rather than 'the student' throughout;
- a minor change to para 12.6 to clarify that the Complaint Review Panel will consider all the evidence from stage 2 and will not seek general comment from the stage 2 investigating officer, as recommended by the OIA.
